

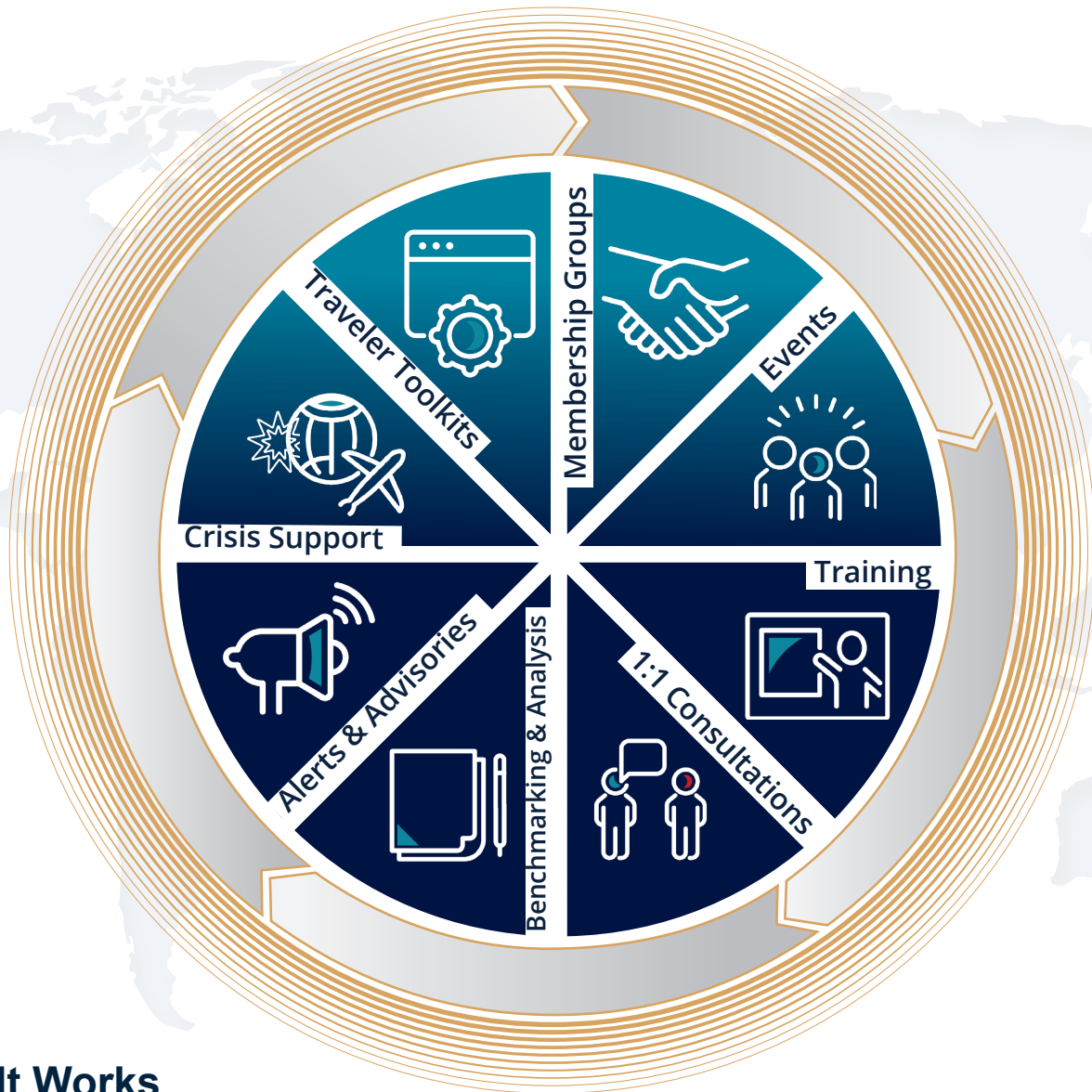


OSAC at a Glance

WORKING TOGETHER TO PROTECT U.S. INTERESTS OVERSEAS

The U.S. Department of State's Overseas Security Advisory Council (OSAC) connects the Diplomatic Security Service with security professionals from U.S. organizations operating abroad. This **public-private partnership** provides ongoing threat awareness, crisis support, benchmarking, analysis, training, and trusted peer network groups to support the safe operations of U.S. interests around the world.



How It Works

Department of State officials have access to embassy, consulate, and inter-agency resources. Private-sector professionals bring insights from their on-the-ground operations. OSAC connects these perspectives into one **information-sharing network** that keeps everyone better informed and able to mitigate threats.

WHO IS OSAC?

- ▶ **34** Council members (31 private sector, 3 public sector)
- ▶ **30+** D.C.-based Program Office staff (Analysts, Program Managers, Threat Coordinators, Civil and Foreign Service Officers)
- ▶ **5,000+** U.S. organizations with overseas operations (corporations, NGOs, universities, faith-based groups)
- ▶ **18,000+** security professionals
- ▶ **150+** embassy & consulate staff-led Country Chapters
- ▶ **14** Common Interest Committees (topic/industry-based)

WHY JOIN?
