OSAC's Response to COVID-19

A crisis highlights your strengths and exposes any weaknesses. Right from the start of this crisis in China in mid-January, our groups like the Pan-Asia Regional Council (PARC) became the best place for members to share timely information and benchmark with one another about actions. Our analyst was getting so many questions and updates from the PARC membership that we instituted a daily update document for OSAC leadership.

The PARC really set a great example of how to deal with a regional crisis. As proof of the quality of information available via the PARC, we saw membership double in February. Clearly, the service and access to information available through the PARC was a great strength of OSAC.

Thanks to the diligence of one of our Council Members, we realized that there was a gap in our approach to sharing this information. We began an education campaign to let all OSAC members know about the PARC's resources, and we activated a new website feature. **Visit OSAC.gov for the latest information on the pandemic.** This includes how to join each of our Regional Councils for the most relevant information on specific countries. You also can email OSAC using a special email group for each region.

This has really been a learning exercise for us in how our members use and expect to receive information. OSAC's strength has always been the feedback and direction we take from the private sector, which has been the one element that has most enabled us to cope with this situation.
